ACTION TAKEN REPORT ON ALUMNI'S FEEDBACK ANALYSIS OF B. A. SYLLABUS

ACADEMIC SESSION 2020-2021

As per the guidelines of UGC and the Internal Quality Assurance Cell of the institution and also for the sole purpose of maintaining quality and standard in all aspects the institution takes feedback from its stakeholders. The Alumni's feedback has been taken during the session 2020-2021 by the Feedback Committee working under the guidelines of the IQAC. The feedback on curriculum of the Alumni is very important as the students have already gone through the syllabus and they have studied it properly.

The feedback committee submitted the entire data making analysis of the responses to the Internal Quality Assurance Cell. The data and the analysis is put in the meeting of the IQAC and also transferred to CDC for taking further action over it. Total 17 pass out from B.A. registered their responses in the form of offline feedback duly filling the forms provided to them.

The outcome of Alumni's feedback analysis in brief as under:-

- Almost all the students found the syllabus very interesting.
- All the students found that difficulty level of the syllabus satisfactory.
- The students have opined through their feedback that the syllabus has been designed keeping in view the academic development of the students.
- They can complete the home-assignments given by the teachers regularly.
- Total 95% students are satisfied with respect to the study material provided to them by the teachers on syllabus directly or through the institutional website.
- 95% students think that the syllabus is designed on the basis of making them employable.
- Total students are of the opinion that after studying the syllabus they become ready to compete at national and international level.
- The complete students are of the opinion that the syllabus is potent enough to create among them the ideal citizens of India.
- Only one student suggested that there is a need for revision of syllabus.

- Some students wrote in their feedback that the college is very good and the teachers in the college are also very good.





- Some students said that all the facilities like canteen, library, laboratory are provided in the college and there is no any issue with respect to education in the college.
