# ACTION TAKEN REPORT ON STUDENTS' FEEDBACK ON B. COM. SYLLABUS

## ACADEMIC SESSION 2020-2021

As per the guidelines of the IQAC of the institution and also for maintaining quality and standard in all aspects the institution takes feedback from its stakeholders. The Students' feedback has been taken on both online and offline mode during the session 2020-2021. But as the students' feedback taken on offline mode appeared to be authentic, the institution has taken it up for analysis and for further action.

The institution has a Feedback Committee working under the guidelines of the IQAC. The students' feedback is usually taken during the even semester so that even the newly admitted students can register their responses in well manner for improvement. The feedback committee submitted the entire data making analysis of the responses to the Internal Quality Assurance Cell. The data and the analysis is put in the meeting of the IQAC and also transferred to CDC for taking further action over it.

The students' feedback from B. Com Students was taken on ten important parameters with respect to the curriculum/ syllabus they have been studying. Total 31 students registered their responses in the form of offline feedback duly filling the forms provided to them.

## The outcome of feedback analysis in brief as under:-

- More than 65% students found the syllabus relevant and excellent while 35% students found it good with respect to the academic development.
- The employability status of the syllabus is good but it is not excellent to a great
- extent as per the feedback taken. The facilities provided by the institutional library gets good credit to have made it available the books and the study resources based on the syllabus.
- The ICT facilities in the institution are good in the opinion of the large number of
- students and excellent for nearly 35% students. The teaching plan and the relevance of time table in the opinion of 50% students is
- excellent while for the other 50% it is good. The feedback shows that the teachers has completed their syllabus satisfactorily.
- The feedback report also clears the fact that the evaluation on the syllabus has been
- taken regularly in good manner.
- The queries of the students were also solved on priority basis
- Overall performance with respect to system of transaction of syllabus as per the feedback taken is satisfactory and there is no any serious issue with respect to it. .
