The feedback from the Students with respect to all the aspects on curriculum and its implementation in the institution as per the guidelines of NAAC asked to the students as a part of questionnaire has been satisfactory. The analytical report of the feedback is as under:

- All most all the students are satisfied with respect to the relevance of the syllabus as per the present need of academic development and the emerging trends. They response is as excellent and good.
