Action Taken Report on Analysis

The feedback from the Teachers with respect to all the aspects on curriculum and its implementation in the institution as per the guidelines of NAAC asked to the Teachers as a part of questionnaire has been satisfactory. The analytical report of the feedback is as under:

- Almost all the teachers believed in the Relevance of the syllabus keeping in view the academic development of the students and the emerging trends in commerce stream.
