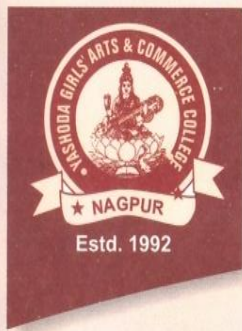

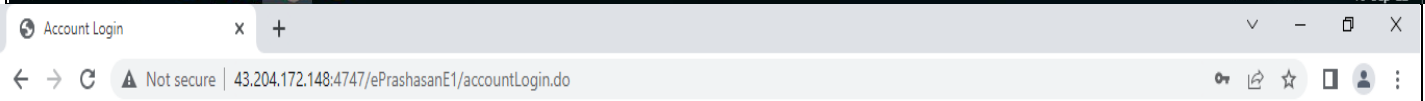
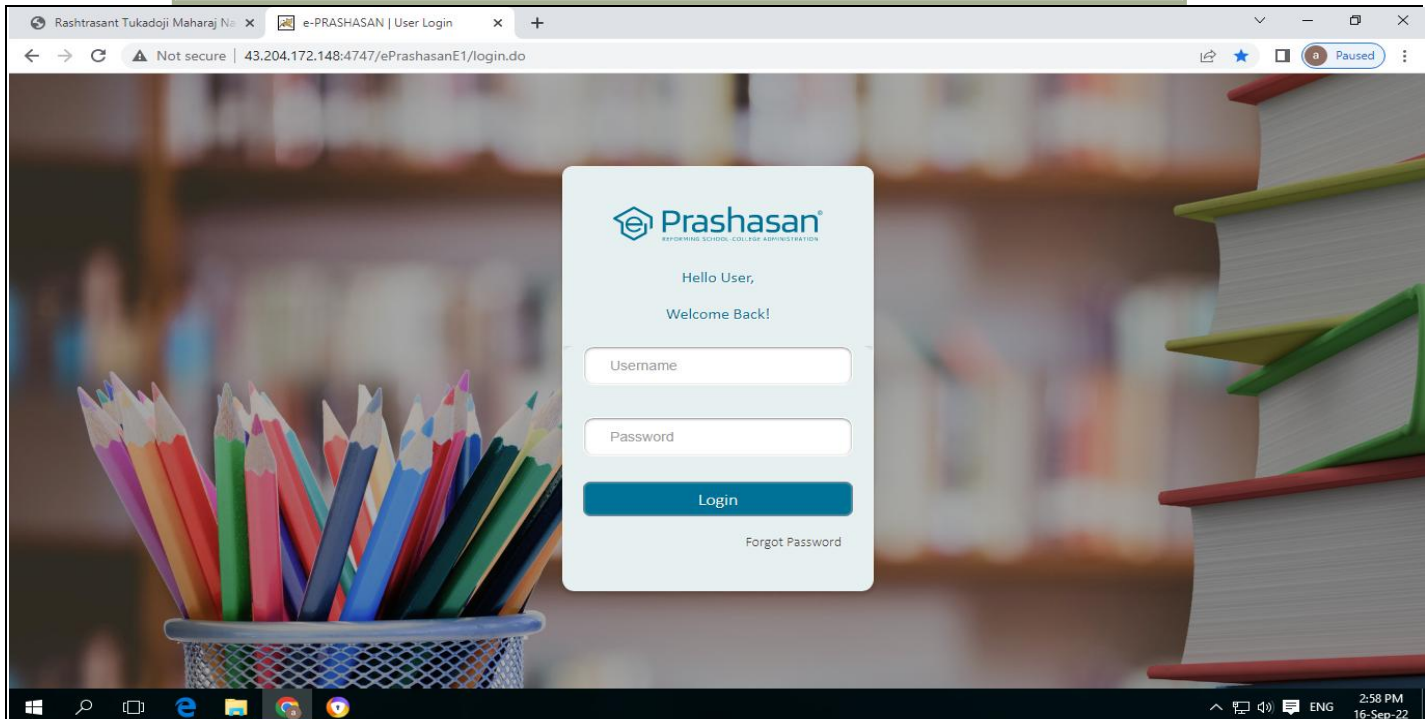
BILL- E-PRASHASAN (OFFICE SOFTWARE)


