

#### <u>NOW THEREFORE IN CONSIDERATION OF THE PREMISES AND MUTUAL</u> <u>COVENANTS AND PROMISES MADE HEREINAFTER THE PARTIES HERETO AGREE</u> <u>AS FOLLOWS –</u>

- The terms of cooperation for each specific activity implemented under this MOU shall be mutually discussed and agreed upon in writing by both parties in a separate agreement, prior to the initiation of that activity. Any such implementation agreements will form appendices to this memorandum of Understanding.
- The development and implementation of specific activities based on this Agreement will be separately negotiated and agreed between the faculties, or institutes, which carry out the specific projects.
- 3. Financial and/or funding considerations shall become the subject of specific discussion and agreement within the framework of a separate implementation agreement. No financial commitment whatsoever, on the part of either signatory to this general document, is intended or implied.
- 4. It is understood that the implementation of any of the types of cooperation stated in clause 2 shall depend upon the availability of resources and financial support at the institutions concerned.
- 5. Should any collaborative research activity under this Agreement result in any potential for intellectual property, both institutions shall seek an equitable and fair understanding as to ownership and other property interests that may arise.
- Each institution shall designate a liaison officer to develop and coordinate the specific activities agreed upon.

AND WHEREAS the Memorandum of Understanding shall remain in force for a period of Three (3) years from the date of the last signature and will be renewed automatically for the period of some duration unless it is revoked with the understanding that it may be terminated by the appropriate authorities of either party giving two (2) months' notice to the other party in writing, unless an earlier
