## MoU with Ayurvan Foundation Nagpur

The Memorandum of Understanding shall remain in force for a period of three (3) years from the date of the last signature and will be renewed automatically for the period of the same duration unless it is revoked with the understanding that it may be terminated by the appropriate authorities of either party giving two (2) months' notice to the other party in writing, unless an earlier termination date is mutually agreed upon. The MOU may be amended or extended by mutual written consent of the two parties.

AYURVAN FOUNDATION, NAGPUR, MAHARASHTRA STATE AND YASHODA GIRLS' ARTS AND COMMERCE COLLEGE, SNEHNAGAR, WARDHAROAD, NAGPUR-MAHARASHTRA STATE wishing to establish relations between the two institutions, hereby agree to cooperate with each other in areas of mutual interest as follows:

1. The purpose of this Agreement is to develop academic, educational cooperation and to promote mutual understanding between the institutions/foundation.

2. Both institutions agree and shall endeavor to promote collaborative activities in academic areas of mutual interest on a basis of equality and reciprocity, which shall include but not be limited to the following:

- a) Awareness of Medicinal plants and its uses.
- b) Disseminating other Ayurvedic plants information.
- c) Conducting Aura Park Visits.
- d) Conducting lectures.
- e) Learning Nursery (Medicinal Plants) Techniques.

3. The terms of cooperation for each specific activity implemented under this MOU shall be mutually discussed and agreed upon in writing by both parties in a separate agreement, prior to the initiation of that activity. Any such implementation agreements will form appendices to this memorandum of Understanding.

4. The development and implementation of specific activities based on this Agreement will be separately negotiated and agreed between the faculties, schools or institutes, which carry out the specific projects.

5. No financial commitment whatsoever, on the part of either signatory to this general document, is intended or implied.

6. It is understood that the implementation of any of the types of cooperation stated in clause 2 shall depend upon the availability of resources and financial support at the institutions concerned.

7. Should any collaborative research activity under this Agreement result in any potential for intellectual property, both institutions shall seek an equitable and fair understanding as to ownership and other property interests that may arise.
