Nothing, therefore, shall diminish the full autonomy of either institution, nor may any constraints be imposed by either upon the other, and nothing in this Agreement shall be deemed to create a partnership, joint venture, or agency relationship between the parties.

Yashoda Girls Arts & Commerce College, Nagpur is an institution which imparts higher education to the girls coming from downtrodden and educationally and economically deprived section of the society in and around Nagpur. The college proposes skill based courses under B. Voc. Degree Programme at low cost and high quality education. The objectives of said programme is to encompass both vocational skill development as well as traditional course work, thereby providing opportunities to the learner's to earn their bread and butter and move directly to the employment sector . It would provide a healthy relationship between two parties providing benefit to the students in terms of knowledge, skill and employment opportunities.

Wishing to establish relations between the two institutions hereby agree to cooperate with each other in areas of mutual interest and are bound by the following terms and conditions:

1. The purpose of this Agreement is to develop academic and educational cooperation and to promote mutual understanding between the institutions.
2. Both institutions agree and shall endeavour to promote collaborative activities in academic areas of mutual interest on a basis of equality and reciprocity.
3. Both the institutions /organizations shall evolve a mutually acceptable schedule to develop programme, holding seminars and exchange visit.
4. Vilas Kulkarni & Associates, Nagpur as far as possible, will provide the opportunity to recruit the student's from Yashoda Girls Arts & Commerce College, Nagpur of the said programme in the field of Accountancy & Taxation on temporary basis as per demand and need.
5. To guide the college from time-to-time to conduct Practical Examination's, Field visit's and to get the detailed knowledge of the Programme in the fields of Accountancy & Taxation.
6. The constitution of the co-ordination committee will be to monitor and revive all activities under the MoU between the two Institutions/Organizations.
7. Yashoda Girls Arts & Commerce College, Nagpur shall continue to co-ordinate with Vilas Kulkarni & Associates and remain updated about their requirement and standard.
8. The terms of cooperation for each specific activity implemented under this MOU shall be mutually discussed and agreed upon in writing by both parties in a separate agreement, prior to the initiation of that activity. Any such implementation agreements will form appendices to this memorandum of Understanding.
9. Financial and/or funding considerations shall become the subject of specific discussion and agreement within the framework of a separate implementation agreement. No financial commitment whatsoever, on the part of either signatory to this general document, is intended or implied.



However notwithstanding the notice of the intent to terminate the memorandum, all writes obligations and corresponding duties and subsisting therein shall be respected and mandated till the finalization and accomplishment thereof.




