- 6) To conduct seminars or workshops in and around Yashoda Girls Arts & Commerce College ,Nagpur with eminent speakers to create awareness about various competitive exams and provide information about our coaching Centre to students and parents.
- 7) Advertisement.
- 8) Other necessary things timely required.

#### 4.2 Role of the College:
