The Memorandum of Understanding (MOU) as outlined in this document is not intended to be a legally binding document. Rather, it is meant to describe the nature and cooperative intentions of those institutions/Industry involved and to suggest guidelines for cooperation. Nothing, therefore, shall diminish the full autonomy of the either institutions, nor may any constraints be imposed by either upon the other, and nothing in this Agreement shall be deemed to create a partnership, joint venture, or agency relationship between the parties.

The Memorandum of Understanding shall remain in force for a period of THREE (3) years from the date of the last signature or it may be terminated by the appropriate authorities of either party giving two (2) months' notice to the other party in writing, unless an earlier termination date is mutually agreed upon. The MOU may be amended or extended by mutual written consent of the two parties.

YASHODA GIRLS' ARTS AND COMMERCE COLLEGE, SNEHNAGAR, WARDHA ROAD, NAGPUR-MAHARASHTRA STATE AND DINSHAW'S DAIRY FOOD PVT. LTD., MIDC, BUTIBORI, NAGPUR wishing to establish relations between the two institutions, hereby agree to cooperate with each other in areas of mutual interest in the form of social responsibility of the industry and the institution as follows:

1. The purpose of this Agreement is to develop academic and educational cooperation and to promote mutual understanding between the institutions/industry purely for the academic purpose.



2. Both institutions agree and shall endeavor to promote collaborative activities in academic areas of mutual interest on a basis of equality and reciprocity, which shall include the following:
 - a) Organizing Visits to the industry/factory.
 - b) Exchange of ideas/knowledge of the functioning of the industry and the production process of the industry for the academic benefit of the students.
 - c) Providing knowledge to the students of the packaging of the products and the processes of its proper distribution etc.
 - d) Internship for students as per the convenience and permission of the industry.
3. The terms of cooperation for each specific activity implemented under this MOU shall be mutually discussed and agreed upon in writing by both parties in a separate agreement, prior to the initiation of that activity. Any such implementation agreements will form appendices to this memorandum of Understanding.
4. No financial commitment whatsoever, on the part of either signatory to this general document, is intended or implied.
5. Each institution shall designate a liaison officer to develop and coordinate the specific activities agreed upon. The designated liaison officers for this Memorandum of Understanding are:




