### Freeship/Scholarship

# ■ Rules and important instructions for Getting Govt. Scholarship and Concession of fees under Freeship.

Facility for applying for Govt. Scholarship and fee concession for backward Class Students (SC/ST/VJ/NT/SBC/OBC) as per Government rules is available in the institution. The students under reservation categories can avail these facilities by going through the following procedure.

- ★ The students should obtain the Scholarship form from the college office and submit the duly filled-in form enclosing required documents within a month after getting admitted.
- ★ The list of documents to be attached with the scholarship form will be displayed on the college notice board.
- ★ The student should verify her eligibility for obtaining scholarship and fee concession before going through the process.
- ★ The students can get guidance for filling the scholarship form from the college office and also from the committee specially constituted for the purpose.
- ★ It must be noted that the scholarship concession is not granted if the form is incomplete, having incorrect information and not fulfilling the requirement of necessary documents. If the scholarship form is rejected due to the above reasons, the college will not be responsible for it.
- ★ It is the duty of the students to ensure the timely submission of the scholarship form whether it is online or manual within the prescribed period.
- ★ In case the scholarship or fees concession form is rejected, the students will have to pay full tuition fees.

The following are the Govt. Scholarship and Concession in Fees likely to be available:

(Important Note:- The College shall not bear any responsibility for grant or rejection of the scholarship)

#### A. National Loan Scholarship.

The students may apply for National Loan Scholarship within 15 days after their admission. Eligibility for this scholarship is as under:-

- a. Student must have passed scoring Minimum 60% marks in the last examination.
- b. She should not be in service.
- c. The amount of scholarship must be refunded as the student start earning money in installments.

## B. Scholarship for the wards of primary and High School Teachers.

In order to apply for this scholarship, the students should have passed the previous examination in first division. She should not be in service. For more details and rules the students may contact the College office.

#### C. State Govt. Merit Scholarship.

For applying for this scholarship the following eligibility and documents are required:-

- a. Students should have passed SSC/HSC examination in first division.
- b. If the student gets minimum 45% in further examination, the scholarship will be continued.
- c. True copy of mark sheets should be attached with the duly filled in application form.
- d. No need of residence certificate or Income Certificate.

# D. Scholarship for Brilliant and Promising Students of Rural Area.

Eligibility conditions for applying for this scholarship are as under:-

- a. The students getting scholarship at High School level are eligible for this scholarship.
- b. The students must have passed HSSC Examination with 65%.
- c. She must pass further examination with minimum 60% marks.

### Concessions

#### A. Chhatrapati Shahu Maharaj Tuition Fees Concession.

For applying to this concession the following documents are required:-

- a. All the Mark lists from Matriculation onwards.
- b. Photo copy of Transfer Certificate.
- c. Annual Income Certificate from SDO.
- d. Annual income of the parents should be below 1,00,000/-.
- e. Photo copy of Aadhar Card.
- f. Domicile Certificate.
- g. Bank Account and Adhar card linkage Certificate.
- h. Xerox of 'Rashan' Card.

(Note: Those students who are not applying for G.O.I Scholarship should apply for Chhatrapati Shahu Maharaj Tuition Fees Concession, otherwise they will have to pay full Tuition Fees Rs. 800/-)

# B. Concession for the wards of Primary, High School Teachers and Junior College Teachers.

The students whose Father/Mother are in service as full time teacher in Govt/Semi-Govt. Schools/ Sthanik Swarajya Sanstha / Corporation/Nagar Parishad/ Zilla Parishad Schools/ Cantonment Schools or in Recognized and Private Aided schools are eligible for

this concession. While applying for this concession the following eligibility and documents are required:-

- a. Student should not have failed the previous examination.
- Certificate to prove from the competent authority that Mother/Father is in service.
- This concession is not given to the students whose parents are retired.

#### C. Freedom Fighter's Concession.

Wards of freedom fighters can avail the concession in tuition fees. The information regarding the eligibility and required documents can be obtained from the college office if the student wishes to apply for this concession.

#### D. Ex-Military Man Concession.

Sons/daughters of ex-military men can be benefitted from this concession. The information regarding the eligibility and required documents can be obtained from the college office if the student wishes to apply for this concession.

#### E. Concession for differently abled students.

For applying for this concession the following documents are required:-

- a. The students who have passed the previous examination with at least 40% marks can apply for this concession.
- b. No caste certificate is required.
- c. Certificate of disability from the surgeon and also income certificate of the parents is required.
- d. The students should contact the college office for more information of documents and eligibility.

# F. Concession given by the Director, Social Welfare Dept. Pune. (G.O.I Scholarship for SC/ST/NT/VJ/OBC/SBC)

For applying for this concession the following documents are required:-

- a. SC/ST/NT/SBC/OBC students can apply for this scholarship /concession.
- b. Caste certificate of the student.
- c. Income certificate of parents (Income should be below Rs. 1,00,000/-).
- d. True copy of Marksheets.
- e. True copy of School Leaving Certificate.
- f. Death certificate in case father is dead.
- g. Caste Certificate.
- h. Gap certificate if there is gap in receiving education.

#### G. Free education for girls up to 12th Std.:-

The girls who belong to the families having only two children can get free education up to Std. 12th.
